## A Membership Dialogue: Answers to Frequently Asked Questions

I invited Martha Randall, our soon to be President Elect, to join me in this column which focuses on issues of membership. She is completing a four year term as Vice President for Membership.

**Randall**: As my term as VP for Membership ends, I am still learning about the organization. Much of what I have learned has been the result of having asked questions about NATS policies and procedures. Since many of you have had, or are asked, the same questions, our executive director and I decided to collaborate on answers that we hope will help you enjoy your NATS membership. Here are some of the questions that are frequently asked.

## Q: I teach in Maryland but my residence is in Pennsylvania. Can I enter my students in the Maryland/DC Chapter **Student Auditions?**

**Vessels**: Members may join and pay dues to any chapter or chapters in which they wish to participate. They simply pay dues to those chapters and this is in addition to the Association dues. Pennsylvania is in the Eastern Region while Maryland and the District of Columbia are in the Mid-Atlantic Region. The portion of your Association dues that goes to the region depends on your mailing address. In this case, the regional portion would go to support the work in the Eastern Region if your mailing address is in Pennsylvania. Randall: This does not occur often enough to have an impact on Regional budgets and it simplifies record keeping.

## Q: If I live in one state but affiliate with a chapter in another state, do I have to join chapters in both states?

**Vessels**: No, you do not.

## Q: I am President of the \_\_\_\_\_ Chapter. How can I verify the NATS membership of teachers in our area? Must a teacher be a member of NATS in order to join a chapter?

**Vessels**: You are able to check the membership of an individual by going to the Membership Directory in the "Members Section" of nats.org. You may also contact our office for an up-to-the-minute verification. Randall: Yes, a teacher must join at the national level before joining a chapter. NATS members can be active in varying degrees, but it begins with national membership. The national dues support the entire organization. Ho wever, a chapter could certainly invite interested prospective members to attend a workshop as an introduction to NATS, but they may not sponsor students in auditions before joining.

## Q: We have a Student NATS Chapter (SNATS) at our University and I am a member. May I upgrade my membership to **Associate Member when I graduate?**

**Randall**: No, student membership is entirely separate from NATS membership. (For information on student chapters contact K. Proctor-Duax.) The recent graduate isw armly encouraged to apply for membership which includes getting a letter of recommendation from a NATS member. (Continued on page 2)

Q: NATS Student Auditions will be held next month in my area. The deadline for a student to enter is in two weeks but I have not yet completed my application for membership. Can you expedite my application in order for my students to participate?

Randall: Our membership secretary, Susan Grizzard, sends me groups of applications in packets. Ordinar ily, I process them in the order in which I receive them. At cer tain times of the year, there are many applications, so there is some backlog in the "pipeline." However, I am quite willing to look at a particular application if the applicant or an auditions chair calls or e-mails me that time is of the essence in meeting a deadline. I do not sor t through all the applications to look for post-its requesting expedited applications; I try to "only handle it once." F ortunately, last July I went to the Executive Office and met with the staff, and we worked out a system whereby the Office does much more of the clerical work, and this has made the process much faster and more efficient. And of course, we can't review an application that we have not received, so tell your colleagues to send it to the Executive Office. Vessels: After an application, letter of recommendation and the \$20 application fee reaches our office; it usually takes about a month to complete the process.

Q: I received a letter stating that my membership application is approved, yet I have not received my membership card and I can't enter the Member's Section of the website. Can you give me my membership number so I can access the Member's Section?

**Vessels**: A new member receives notification of acceptance, but is not reported as a current member until current dues are paid. At that point, the new member will receive a membership card with a membership number allowing the member access to the "Members Section" of **nats.org**. This situation could also be the cause for inquiries we also get from regional governors. It is possible for governors to receive a membership report giving the names and addresses of new members, later to receive a list saying that a new member has not paid current dues. To avoid any misunderstanding, a newly accepted member needs to submit dues payment to our office as soon as possible.

## Q: My membership lapsed in 1988 and I would like to rejoin NATS. Do I need to send a membership application?

**Randall**: If your membership lapsed, all you need to do to reinstate is to contact the Executive Office and pay the current year's dues plus a \$20.00 reinstatement fee. If you previously resigned your membership, the reinstatement fee is waived. If the Office has no record of membership (and sometimes teachers think the y have been members, when in fact they were not), then a completed application would be needed.

- Q: Can I apply for membership online? Vessels: Online applications are not available. Prospective members may download all the membership materials, including all the necessary forms, and complete the information requested on the forms, but in order to ensure prompt attention by the Membership Committee, the materials should be mailed to the Association Office, along with the completed letter of recommendation, and payment of the \$20 application fee.
- Q: I am an Associate Member. Do I need to reapply in order to change my classification to Full Member?

**Randall**: An Associate Member needs only to contact the Executive Office and submit a letter of request for an upgrade of membership, explaining what now qualifies him/her for Full Membership. Usually, this has to do with the number of years of teaching experience as explained in the application. (*Continued on page 11*)

## **Review of National Workshops**

It has been a very busy year for NATS National Workshops! The ten-month period from March 2003 through January 2004 saw four major events in Salt Lake City, Princeton, Flagstaff and Miami, attended by well over 400 dedicated NATS members.

## Miami, January 2004: New Music for Voice

Florida International University and local coordinator Robert Dundas were the hosts for this exceptional event, which featured live performances of over 100 new and recent compositions. Several graduates of the NATS Intern Program were featured as soloists in presentations by Judith Carman of music that was "hot off the press." The extensive workshop faculty also included Lindsey Christiansen, sharing overlooked music from historically significant composers, and **Phyllis Bryn-Julson**, who spoke to the roots of new music and led an enlightening master class. Several south Florida NATS members were also presenters, including Cayce Benton (songs of Ricky Ian Gordon), Ester Jane Hardenbergh (songs of Richard Hundley), Mark Aliapoulios (challenges of new music), and Kimberly Daniel de Acha (music theater repertoire). Following a call for submission of proposals, Joyce Andrews, Carol Lines, Lee Thompson, Linda Lister, Susan Kane and Steven Harlos were all invited to present lecture recitals. The workshop climaxed with a gala recital by acclaimed soprano Joan La Barbara and FIU's NODUS Ensemble, which included two world premiere performances: Breath, by Morton Sobotnick, and Transcending *Time*, by Orlando Jacinta Garcia. In addition to the stimulating program, workshop attendees were delighted with the warm hospitality and exceptional facilities provided by Florida International University—not to mention temperatures in the mid-seventies while much of the country suffered through a bitter cold snap.

## Flagstaff, July 2003: Spanish and Portuguese Song

Judith Cloud served as local coordinator for this workshop, hosted by Northern Arizona University and attended by over 60 devotees of songs from Spain, Central and South America. René Aravena helped people refine their Spanish diction and increase their knowledge of Turina, Falla and other Spanish masters, while Stela Brandão discussed elements of Portuguese lyric diction and Brazilian song. Suzanne Rhodes Draayer shared her wealth of information about the songs of Joaquin Rodrigo and introduced workshop attendees to the music of nineteenth-century Spanish composers.

The songs of Argentina were the specialty of **Allison Weiss**, and **Lori McCann** shared her insights into Zarzuela. Brandão, Aravena and Draayer all contributed master classes. A spectacular recital of music from South America by tenor **Ricardo Pereira** and pianist **Rita Borden** was a true highpoint.

## Princeton, June 2003: Introduction to Vocology

Westminster Choir College and local coordinator **Margaret Cusack** were hosts to nearly 160 for this stimulating event. As an overview of the new and emerging field of vocology, this workshop condensed several months of graduate-level study into just a few days—needless to say, it was a whirlwind tour! **Stephen Austin** began the workshop with an exploration of singing anatomy, followed by **Scott McCoy** and a discussion of acoustics, resonance and voice analysis. Many people returned the first evening for an ad hoc session to play with analysis instruments from Westminster's renowned Voice Laboratory. **Dr. Anthony Jahn** informed everyone about voice disorders and **Dr. Anat Keidar** spoke to techniques for voice rehabilitation. **Neil Semer** led a master class in classical and music theater singing techniques and **Marvin Keenze** helped everyone refine their teaching methods. **John Nix** wrapped up the workshop by addressing the practical application of vocology in the teaching studio. Metropolitan Opera star **Sharon Sweet** and pianist **James Goldsworthy** presented the feature recital. Interest in Vocology is very strong—we will probably schedule a reprise of this workshop on the west coast sometime in the near future.

## Salt Lake, March 2003: Children, Teens and Adults in the Private Voice Studio

This workshop was a ground-breaking collaboration between NATS and MTNA, the Music Teachers National Association. Local coordinators Thomas Pike and Lana Wilkinson provided valuable assistance in planning and executing the event and helped find some extraordinarily talented children, teenagers and young adults for participation in master classes. Robert Edwin served as a primary faculty member, presenting daily classes in age-appropriate repertoire, as well as a master class for young children and a joint session with Cindy Dewey on studio management and marketing. Clayne Robison and Clifton Ware demonstrated group teaching techniques for teenagers and adults, while Kenneth Phillips helped with methods for "teaching kids to sing." Panels including Martha Randall and the other faculty members discussed the changing voice and preparing college entrance auditions, and Robert McIver presented a master class with young, aspiring professional singers. To round out the practical aspects of studio management, accountant Mark Springer fielded questions about taxes and other money matters. NATS and MTNA co-sponsored a recital by soprano Sari Gruber, who delightfully proved one need not possess a voice of gargantuan proportions to fill a barn-sized hall with stunningly beautiful sound. NATS looks forward to joining with MTNA again at their upcoming convention in Seattle, scheduled for April, 2005.



## Call for Papers

The 6th Pan European Voice Conference (PEVOC) will take place at the Royal Academy of Music in London from 31<sup>st</sup> August to 3<sup>rd</sup> September 2005. The programme will include presentations from invited speakers, masterclasses, workshops, posters, free papers, and an Exhibition.

We are now inviting submissions for the free paper, poster, and workshop sessions. The language of the Conference is English.

- *Free papers* should be no longer than 15 minutes plus 5 minutes for questions and comments. They will be grouped according to topic. Each session will have an invited keynote speaker as well as two named discussants who will open the questioning and act as joint Chairpersons.
- Please note that we prefer that presentations are not simply read from a text.
- Workshops will last 45 minutes each, and each workshop will be scheduled to run twice, to double the potential numbers who can participate.
- Posters will have a dedicated timetabled session where discussions can take place between the
  authors and Conference participants. In addition, there will be 2 prizes of £250 in memory of
  Gunnar Rugheimer for the best poster as judged by a panel from the British Voice Association.

Authors will then be invited to prepare full manuscripts (to be submitted before 1 February 2005) for publication in the Conference Proceedings. Late submission will prejudice publication.

## **Report of Field Activities**

This past year has been particularly exciting for the Student NATS (SNATS) organizations. I have had approximately 75 inquiries about starting SNATS groups throughout the United States and Canada. Most who contact me are NATS members, but there have been many students both in undergraduate and graduate programs who want information. Even though SNATS has few requirements and little structure, I am confident that the National Association of Teachers of Singing Board is doing the right thing in encouraging the formation of SNATS groups! This is no doubt a niche market, but an important opportunity to learn about vocal health, vocal repertoire, issues of style, and information on auditioning and performing. Because NATS activities serve members so well, our students could also benefit from the NATS workshops, conventions, and publications like the Journal of Singing. Getting together for discussions pertinent to singing and its creative issues satisfies teachers and students alike.

Starting a SNATS group is easy, but it does require a NATS member in good standing to initiate the organization. The NATS Board requires no dues but asks that each chapter purchase at least one annual subscription to the Journal of Singing. Frankly, leadership is not a problem for most groups because of the enthusiasm of the students. Although I would like to meet each of these groups personally, I hope to meet some SNATS members this summer at the NATS national convention in New Orleans! Please note that SNATS group teacher-advisors will be invited to get together sometime during the convention to share ideas. Please let me know if you will be attending, and if you are bringing any SNATS students. I'm really looking forward to meeting everyone!

Although many grant requests are repeated annually by the same chapters/districts, I would encourage you to apply even if you have never applied before. The forms are on the <NATS.org> website or I can send them to you. You could receive up to \$500 if you provide matching funds from your chapter or district. ## A CALL TO ACTION FROM THE NATIONAL MUSIC COUNCIL

Through its membership in the National Music Council, the **National Association of Teachers of Singing, Inc.**, is linked to the American music community at large. With the cooperation of its member organizations, the National Music Council promotes and supports music and music education as an integral part of the curricula in the schools of our nation, and in the lives of its citizens. Additionally, the Council provides for the exchange of information and coordination of efforts between its member organizations and speaks with one voice for the music community whenever an authoritative expression of opinion is desirable.

It is not often that the National Music Council calls upon the individual members of its constituent organizations to take specific action, but circumstances at this time compel me to address you directly in order to ask for your assistance. The future of America's composers and songwriters —and by extension the future of American music itself— has never faced a graver threat than the one it is facing today from illegal Internet file-sharing. For every member of the extended U.S. music community, from creators, to educators, to music-lovers, the time to raise our voices in support of America's music is now!

Enormous damage is being inflicted on our industry by illegal Internet activity. Some two billion incidents of electronic music shoplifting occur each month. This rampant piracy is not only displacing sales of music through normal retail chains, but also strangling the growth of innovative and licensed Internet music services, which cannot compete with "free" access.

The result has been an economic downturn of more than thirty percent across the music community, undeniably traceable in significant part to this epidemic of theft. Thousands have lost their jobs, and many thousands more are about to. As one bleak example among many, Music Row in Nashville —the most concentrated gathering place for songwriters of all genres in the country— is growing quieter each month as "for rent" signs replace ongoing businesses at an increasing pace.

Yet, despite these very troubling signs, the media unfortunately persists in portraying the issue of illegal Internet activity most frequently as a "victimless crime," a David and Goliath tale of large corporations versus consumers where those suffering the most —creators and small businesses— are thoroughly ignored. That is a situation that cannot be permitted to continue. The message that we must deliver now to our Congressional representatives, to the White House, and to the public is that the real victims of electronic music theft are individuals at every economic level:

- Songwriters
- Recording Artists
- Musicians
- Independent Retailers
- Hundreds of Thousands of Americans employed in supporting positions throughout the music industry, and their families

Without the means to support themselves through their music, creators will inevitably be forced to abandon their careers. The end result will be the severe diminution of American musical creativity and innovation, a narrowing of musical diversity, and eventually the destruction of the American music community itself (with severe economic ripple effects throughout the intellectual property community that comprises 5% of the U.S. GNP spread among tens of thousands of large and small businesses). That bleak future is a calamity that we urge you to help us prevent.

## A Membership Dialogue: Answers to Frequently Asked Questions (continued from page 2)

# Q: I received the application packet in the mail and would like to know if I can fax the completed form or must it be sent through the regular mail? Also, does the member, who writes the recommendation letter fill out the second page, or does it have to be on a separate blank piece of paper?

**Vessels**: Thank you for your inquiry. Since the application f ee of \$20 should accompany the application, it would be problematic to fax the application form unless you include either VISA or MasterCard information with the fax. There is a 4% service charge for credit card payments. It is best, also, if the recommendation letter accompanies the application. It does not need to be on the form, which is largely intended for informing the person writing the letter what information is needed. It may be on a separate piece of paper and should cover the information requested on the form.

## Q: Why can't I just send in my resume? The resume usually contains both more and less information than is needed for applying for NATS membership.

**Randall**: We need to know the number of students taught and that is rarely in a resume, and we do not need all the details necessary in a curriculum vitae. Storage space does become an issue as original applications are filed in the Executive Office. The only exception is when applying for full membership under A. (6) c in the NATS Membership Brochure.

### Q: What benefits do Affiliate Members have?

**Randall**: An Affiliate Member can stay in touch with what the singing community is doing, be included in the Web Directory, receive publications, attend workshops and conventions at a reduced rate, and can do everything a full member can do except sponsor students in student auditions or competitions, vote, or hold office.

## Q: Where do I send letters of recommendation; find out about whether my dues are current; check on my subscription to JOS; or change my address?

**Vessels**: Contact any of us in the Executive Office. The phone number in the office is (904) 992-9101. Send fax transmissions to (904) 992-9326. The office address is 4745 Sutton Park Court, Ste. 201, Jacksonville FL 32224.

Randall: In closing, as time approaches for the 48th National Con vention(J uly 8-12), there has never been a better time to join NATS.
