Dillard Announces Executive Director Appointment

Dr. Kandie Kearley Smith has been named by President Dillard to succeed Dr. William A. Vessels as the next executive director of the Association. Vessels will retire December 1. Smith will join the NATS office staff at the beginning of October.

Smith holds a bachelor of music degree in voice from Stetson University in Deland, Florida; a master of music degree in opera from the University of British Columbia; and a doctorate in musical arts from the College-Conservatory of Music of the University of Cincinnati.

After ten years of successful experience in every facet of arts administration, she possesses a wide range of experience in concert and special event planning; budget management; personnel and payroll issues; contracts; marketing; public relations; promotion; box office management; fundraising and grant writing; volunteer coordination; and board management.

She was the assistant general manager of the Seaside Music Theater, Inc. in Daytona Beach; managing director of the Daytona Beach Symphony Society, Inc.; program director of Women's Programs and Services at the University of Cincinnati; and operations director, box office manager, and administrative assistant for the Florida International Festival in Daytona Beach.

In addition to her onstage singing experience, Smith taught voice at Stetson University; the Stetson University Community School; Daytona Beach Community College; Brewton-Parker College in Mount Vernon, Georgia; was a graduate teaching assistant at the University of British Columbia; and held choir director positions at churches in Daytona Beach and in Cincinnati.

The executive director search committee held a nationwide search earlier this year and met last May in Jacksonville to interview finalists for the position. Members of the committee were Chairperson Roy Delp; President Jane Dillard; Gale Odom; Carl Swanson; Robert Edwin; Martha Randall, and Margaret Dehning. The Board of Directors unanimously approved the recommendation of the search committee, and President Dillard made the appointment.

2004 FISCAL YEAR AUDIT SUMMARY

The 2004 financial audit of the Association has been completed, and published copies of the report were furnished to members of the Board of Directors by the independent audit firm of Lucas, Herndon, Hyers, and Pennywitt, Certified Public Accountants, Jacksonville, Florida. The entire unqualified audit report and opinion letter of the auditor is available for members to review in the Executive Office of NATS in Jacksonville, Florida, as well as from members of the Board of Directors. The following summary of the details of the Audit are extracted and summarized below. The auditor's report, and notes that accompanied the report, are an integral part of the audit statements.

In 2003, the Board approved a two-stage dues increase. The first stage went into effect with the 2004 dues, and the second stage will go into effect in 2006. Starting with the next dues cycle, the annual dues amount will increase by \$8.00. The Board, in 2003, believed that this final stage of the increase should be enough to avoid future deficits, as long as the Association continues to grow as we have since the beginning of the decade. One sure way to keep from requiring another increase in future years is to become more proactive in recruiting members and in supporting our workshops and conferences.



Of course, there is always some discussion whenever dues are raised. Let me innumerate some ways in which the current economy is affecting our costs.

- 1. Our Association dues have been low, and are still low, in comparison with those of other similar professional associations.
- 2. Can you name any commodity that has decreased or remained the same in cost over the past four or five years? One example is the vendor of our office supplies told us recently that the cost of paper is going up about 30% in the near future.
- The Board wanted to have adequate financial resources to upgrade salaries and benefits for our executive office staff, especially at a time when the Association would be searching for a new executive director.
- 4. Postal costs have risen, and will continue to rise, in the near future. For example, it costs, on the average, about five dollars each to send one copy of the *Journal of Singing* to our international members and subscribers.
- 5. Both the number of members and *Journal of Singing* subscribers continue to rise each year; therefore, the cost of serving these constituents continues to rise.
- 6. The Board does not want to cut programs in order to hold dues at a static level. In fact, the members of the Board would like to see the Association expand benefits to members and programs.
- 7. The Association has experienced deficits in two of the past three years. We are far from being in a crisis situation, but in order to maintain our financial stability, we need to avoid deficits in the future, and we need to continue to grow our reserve funds.

The Association has come a long way in the past fifteen years since I took over the daunting task of being your executive director. I have thoroughly enjoyed every minute. Our leadership is first rate, and they have made my job easy, as have the two staff people, Deborah Guess and Susan Grizzard, and others before them, on whom I depend each day. Thanks to you all. I know you will be as kind to our soon-to-become executive director, Kandie Kearley Smith, as you have to me.

MEET THE CANDIDATES

For the Office of President Elect

Scott McCoy, DMA, is Professor of Voice and Pedagogy at Westminster Choir College of Rider University, and a member of the American Academy of Teachers of Singing. His multimedia text, *Your Voice: An Inside View* (2004), is used extensively in classrooms worldwide.

Statement as President Elect:



NATS has helped me become a better teacher and singer. Chapter and Regional auditions were important milestones in my musical education. Interactions with peers, combined with feedback from so many experienced teachers, were truly invaluable and left lasting impressions—as did the strong collegiality exhibited by all participants.

As a young teacher, NATS provided a network of support that transcended my local campus community. The feedback my students received at auditions often alerted me to issues that had previously escaped my attention. Workshops, local to national, stimulated my creativity and enhanced my skills. National Conferences introduced me to many of the most prominent people in our field, all of whom were eager to share their experience and lend their support.

It has been my privilege in recent years to participate in NATS at new and exciting levels. Beginning as NATS Governor of Iowa, I have subsequently become a member of the editorial board of the *Journal of Singing*, a member of the NATS Voice Science Advisory Committee, a master teacher for the 2005 NATS Intern Program, served two terms as Vice President for Workshops, and am the Program Chair for our next two National Conferences. While at times taxing, this work has been a constant source of personal renewal and impetus for artistic growth. I am deeply honored to be nominated for the office of NATS President Elect. Through the coming years, I will do my best to ensure that all teachers of singing feel welcome and supported by NATS, including private teachers, non-classical specialists, and academics.

For the Office of Secretary/Treasurer

Allen Henderson was recently appointed professor and chair of the Department of Music at Georgia Southern University. From 1994-2005 he was professor at Austin Peay State University where he taught voice, opera and was chair from 2000-2003. Henderson served as Mid-South regional governor from 2003-2005, and prior to that was Tennessee governor. Henderson holds degrees from Carson-Newman College(BM), The University of Tennessee(MM), and the College-Conservatory of Music, University of Cincinnati(DMA), and was a 1993 participant in the NATS Intern Program. An award winning baritone, he was winner of the 1995 NFMC Artist Awards, NATSAA regional runner-up, regional finalist in the Metropolitan Opera auditions, and winner of the Corbett-Treigle Opera competition while at CCM. He has been a fellow at the Bach Aria Festival and the Ravinia Festival. As director of opera at APSU, Henderson produced full productions of *Le Nozze di Figaro, Die Fledermaus, Candide, Trouble in Tahiti, Trial By Jury, and Game of Chance*. In 2004 he directed the



premier of *A Perfect Plan* by Seymour Barab, with the composer in attendance. He has created roles and directed premieres of the chamber operas *St. Nicholas and Good King Wenceslas* by Richard Shepherd and Mark Schweizer, and directed the premier of *Diaries* by Jeffrey Wood. Dr. Henderson can be heard on the recordings of both of the chamber operas, on Aeolian Records' release entitled *Dimensions*, and on his recording with guitarist Stanley Yates entitled *Shadows*, featuring works by John Rutter, Michael Fink, and Castelnuovo-Tedesco.

Dr. Henderson has been the recipient of several fellowships and grants in recognition of his teaching and research including a Grant by APSU to conduct research on the vocal music of John Alden Carpenter.

For the Office of Vice President for Workshops



Dr. Suzanne Rhodes Draayer, soprano, teacher, author, editor, is professor of music at Winona State University in Winona, Minnesota. She earned a Doctor of Musical Arts in vocal performance, pedagogy, and literature from the University of Maryland. She holds a Master of Science in vocal pedagogy from Peabody College of Vanderbilt University, and a Bachelor of Music from Furman University.

Suzanne is active professionally in NATS, and has been a member since 1976. After having served in many capacities on the state level, she was elected governor of the North Central region in June 2002. At the NATS National Conference in San Diego (July 2002), she presented two poster papers: "Joaquín Rodrigo, 1901-1999," and "Who was the Schubert of Nineteenth-Century Spanish Song?" At the NATS Summer

Workshop in Flagstaff, Arizona (2003), she presented two lecture recitals and a master class. The workshop theme was "Spanish and Portuguese Song of Europe and the Americas." Suzanne presented poster papers at the New Orleans NATS Conference (July 2004) titled, "When Louisiana Was Spanish—Poetry of the Golden Age in Joaquín Rodrigo Song Settings," and "Canciones de España—Songs of Nineteenth-Century Spain for Studio and Stage." Suzanne presented a lecture recital on nineteenth-century Spanish song at the ICVT-6 in Vancouver, B.C. in August, 2005.

An avid advocator of Spanish music, Suzanne has presented workshops for many NATS chapters on Spanish song, and she has written extensively on the subject. Several of her articles have appeared in the *Journal of Singing*. Her book, *A Singer's Guide to the Songs of Joaquín Rodrigo* is published by Scarecrow Press (1999). Her anthologies, *Canciones de España—Songs of Nineteenth-Century Spain*, volumes I and II, (Scarecrow Press, 2003, 2005) offer singers, voice teachers, and their audiences the opportunity to luxuriate in the melodies and rhythms of Spain.

For the Office of Vice President for NATSAA

Donald Simonson, Professor of Voice at Iowa State University, chairs the Voice Division and teaches voice, voice pedagogy, vocal literature, and directs musical theater. He received the B.M., B.M.E. and M.M. from Drake University, the D.M. from Northwestern University, and did advanced study at the Hochschule für Musik in Vienna. Principal teachers were Marion Hall, Otto Edelmann, Norman Gulbrandsen, and Berton Coffin. He regularly performs leading roles with opera companies and appears with orchestras and chamber ensembles throughout Europe, America, Australia and the Far East, such as the Warsaw Philharmonic, the Wiener Philharmonia Solisten, the Clemencic Consort, and the Austrian National Radio Symphony. Recent concert and recital tours have been in Austria, the Czech Republic, the Republic of China, and in the U.S (Florida, Illinois, Iowa and Arizona). He has recorded for the Musical Heritage, Harmonia Mundi, Musique D'or, and CBS/Sony Classical labels. He maintains an active research laboratory at ISU in vocal acoustics. Results of his investigations have been presented at national and international conferences and published in leading scientific journals.



An active member of NATS for 25 years, Simonson has served the organization in a variety of capacities. He served two terms as the lowa District Governor, two terms as Governor of the Central Region and member of the National Board of Directors. In 1998 Simonson conceived and coordinated the first ever "Call for Papers" for a NATS National Convention. Currently, he serves as the coordinator and chair for the "Call for Papers" for ICVT6, to be held in Vancouver in August of 2005, and for the 49th National NATS Convention, to be held in Minneapolis during the summer of 2006. He has also served as a member of numerous NATS ad hoc committees, most recently the "Call for Presenters" selection committee for the 2006 Minneapolis Convention.

For the Office of Vice President for Discretionary Funds & Field Activities



Carl Swanson, holds a Bachelor of Music degree from the University of Rhode Island and a Masters of Education degree from Suffolk University. He is currently the Associate Editor of *The Private Studio* column of the *Journal of Singing* and the New England Region Governor of NATS. He has served as the Rhode Island District Governor of NATS and as Vice Chair of two New England Region Summer Conferences. He is a founding member of the Rhode Island Chapter, where he served as Secretary, Vice President, and President. Carl also serves as the webmaster of New England NATS' website. As New England Governor he has organized two regional conventions. Nationally, he has served on NATS' Executive Director Search Committee and the Convention Location Committee. He serves on the Membership Committee and was chair of the Resolutions Committee for the 2004 NATS Convention in New Orleans

Carl currently teaches voice at his home studio in Wareham, Massachusetts and at Northeastern University in Boston. A tenor, Carl has made numerous opera and oratorio appearances throughout New England. His past engagements as a conductor include Chorus Master of Opera Rhode Island, Music Director of several churches and temples, several engagements as Choral Director for All-State choruses, and Director of the Providence Gay Men's Chorus. His recordings include Handel's *Messiah* and Mendelssohn's *Elijah*.

NATS has always been an important part of Carl's teaching. He has been a loyal member since 1982, giving freely of his time during these years. Carl is proud to be following in the footsteps of Dr. Kathryn Proctor Duax who has worked diligently to make the membership aware of NATS Discretionary Funds and Student NATS Chapters. It is his hope to continue to elevate both of these programs and place them firmly in the focus of the membership.

ANNOUNCING THE 2006 NATS INTERN PROGRAM June 13-23, 2006

The NATS Intern Program is an exciting and innovative venture that seeks to pair experienced and recognized master teachers of voice with talented young members of NATS. Within a format designed to promote the dynamic exchange of ideas and techniques, the goal is to improve substantially the studio teaching skills of these promising young teachers. Each intern will teach four lessons to two students (one male and one female) and perform in a master class under the supervision of a master teacher. In addition, the master teachers, our vocal literature liaison, Cynthia Vaughn, and special guests will present special lectures and demonstrations. Interns chosen will be responsible for their own expenses, although financial assistance will be available through the NATS Foundation for housing and meals. Interns may also request financial assistance from their NATS chapters or regions as well as from their institutions of employment for travel. The interns' tuition expenses for this program are completely covered by NATS, Inc., and the NATS Foundation. Again this year, one of the master teachers will specialize in the needs of the private studio teacher including teaching non-classical styles, and three interns who specialize in private studio teaching will be selected to work with that master teacher.

Twelve NATS teachers will be chosen to participate in the 2006 NATS Intern Program.

Requirements are as follows:

- An applicant must be a member of NATS in good standing with no more than five years of full-time teaching or the part-time equivalent. Working as a graduate teaching assistant does not count towards the five-year limit. Holding a Master's Degree or higher is preferable but not required.
- The application must include the completed application form (available in a downloadable version at www.nats.org, in the Fall 2005 Inter Nos, or by mail from NATS, Inc., 4745 Sutton Park Court, Suite 201, Jacksonville, FL 32224), a résumé, two references, and a recent audio recording, a 15-minute audio CD of your singing with piano accompaniment in three languages, including English. Private studio teachers should include at least one non-classical song. If you cannot send a CD, a cassette-taped recording is acceptable. Applicants must not send video recordings.
- All applications must be sent by February 1, 2006 (postmark deadline).

REPORT OF DISCRETIONARY FUNDS AND FIELD ACTIVITIES NATIONAL ASSOCIATION OF TEACHERS OF SINGING Kathryn Proctor Duax Vice-President for Discretionary Funds and Field Activities

It has been a wonderful year in NATS with much creative programming, thanks to the support of the NATS Discretionary Fund. In 2004 twenty-five requests for discretionary funding requests were funded across North America, from Canadian chapters in the Maritime Provinces and Calgary, to the United States where most regions and many chapters were represented. More than 2600 teachers and students participated in these programs. They included numerous masterclasses, workshops and recitals featuring Shirlee Emmons and Alma Thomas, Fiora Contino, Gale Odom, Cynthia Dewey, Marina Gilman, Suzanne Draayer, Donna Brown, Sherrill Milnes, Darryl Taylor, Patrick Mason, Barbara Honn, Stephen Austin, Elizabeth Blades-Zeller, JoAnn Ottley, Judith Carman, and Tim Caldwell.

In 2005, approximately one-third of the \$10,000 grant budget has been awarded as of July 15. This pattern is typical, allowing for grants in the fall semester, which has proven to be the greatest grant request period. Discretionary Funding is a key ingredient in the educational mission of the National Association of Teachers of Singing. Many events simply would not take place without supplemental funding. It appears that information about the supplementary funding is well disseminated through the web site and *INTER NOS*. Many thanks to the hard working volunteers in NATS! [NOTE: Application forms and expense vouchers are available online from the <NATS.org> web site, or from me at <kpduax@charter.net>.]

Student NATS (SNATS) organizations have grown considerably this year to twenty-one chapters. Numerous inquiries about student chapters continue from teachers and students via the NATS web site. Several chapters have developed outstanding programs. [See the Spring 2005 INTERNOS for news from individual chapters.] I recently learned that the University of Minnesota is forming a new SNATS chapter under the leadership of longtime NATS member Clifton Ware. It is time for NATS members to fully realize the potential of our students, their local SNATS chapters, and their interest in NATS activities. This is a most worthy grassroots program with considerable potential for growth which will benefit the parent organization. In academic year 2004-2005, the NATS Foundation supplied a one year gift subscription to the Journal of Singing to student NATS chapters to encourage students to read the articles and participate in NATS. Many thanks to the Foundation for this wonderful gift!

The professional and educational vision of the National Association of Teachers of Singing must continually grow and develop. I urge each NATS chapter that sponsors a SNATS chapter to pay for a subscription to the *Journal of Singing* for these student chapters. NATS chapters should encourage SNATS members by inviting them to participate in their chapter activities. Our teaching opportunities and professional awareness increase tremendously within the SNATS organizations. Let's get our students involved with NATS earlier! If you don't have a SNATS chapter, think about starting one! Any NATS member may start a chapter. Remember, the voice students of today are tomorrow's NATS members. THE VAN L. LAWRENCE FELLOWSHIP

The Van L. Lawrence Fellowship was created to honor Van L. Lawrence, M.D. for his outstanding contribution to voice, and particularly to recognize the importance of the interdisciplinary education he fostered among laryngologists and singing teachers. - * Also attach a detailed curriculum vita.



Inspiration is a truly wonderful and rare event, and it is with thanks that I reflect upon the master teachers, colleagues and students who made the recent NATS Internship an unforgettable and invaluable experience for me.

To "be good" is to pursue excellence. I would like to note briefly some of the unique opportunities for professional development which the Internship offered this summer. Presentations included the following:

- Jane Dillard offered an insightful round-table session on the art of teaching and communication. Potential
 teaching scenarios were posed by Ms. Dillard and this facilitated engrossing and informative discussion
 on effective teaching strategies.
- Scott McCoy introduced the relationship between resonance, vocal physiology, acoustics, and formants and potential application in the vocal studio. His presentation included multi-media information entitled "Your Voice, an Inside View" (Inside View Press, Princeton, NJ).
- Robert Edwin gave an introduction to healthy non-classical vocal technique and pedagogy. Mr. Edwin
